Use Fertigate W as a late season fertigation input where trees or vines require additional Nitrogen and Potassium as well as maintenance quantities of other Macro elements.

To dissolve, add the fertiliser to the water at a maximum concentration of 1 kg per 4 litres of water, and stir until dissolved. The use of hot water speeds up the process.
