DIRECTIONS FOR USE

Antifoam 'A' is an aqueous emulsion of a polydimethylsiloxane fluid for use as an antifoam agent in agricultural spray systems. It is a free flowing ready to use liquid that may be added before or after foaming occurs. Antifoam 'A' should be added directly to the spray tank. The amount to use varies with the chemicals being used but will usually be 10 -100mls/100L of water. For most applications the lower rate will be satisfactory and it is recommended that the 10mls/100L rate is initially tried for all applications and that this is increased only as necessary.
