Contains: Nitrogen 5.7%, Phosphorus 1.3%, Potassium 4.2%, Magnesium 7.6%, Iron 1.5%, Zinc 1.7% (as Zinc Sulphate 47g/kg), Boron 0.05% (as Boric Acid 3.0g/kg), Manganese 0.04%, and Sulphur 12.7% as water soluble powders. Iron is chelated to ensure rapid plant availability.

DIRECTIONS FOR USE:

Kiwi Combo has been developed as a foliar feed for application to horticultural crops for early and mid-season use. It should be used as part of a season long foliar program and should also be applied before and after periods of stress such as drought, low temperatures, excess rain etc. It is designed to be absorbed by the plant foliage and will not burn or scorch plant growth when applied at recommended rates.

APPLICATION RATE	WATER RATE
5kg per hectare	Minimum 100L per hectare

MIXING INSTRUCTIONS

1. Add one quarter of the spray water to the tank and begin agitation.
2. Either pre-dissolve the powder in 5 times its volume of water or add to the inlet screen and wash into the spray tank with the remainder of the water.
3. Add any trace elements next, starting with solids, then dispersion and finally solutions.
4. Lastly add any chemicals.
5. Apply immediately. Do not store mixed chemicals.

Note: Where a product datasheet specifies that the products should be added in a different order than above (eg. Copper hydroxide) then follow those instructions. If in any doubt about compatibility or unfamiliar chemicals are being used then a trial mix is recommended.
