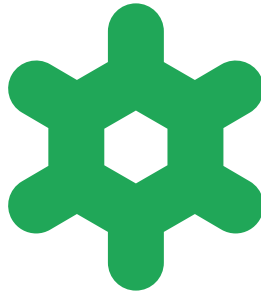

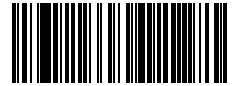

HAZARD CLASSIFICATIONS: 5.1.1C, 6.1E, 8.2C, 8.3A, 6.5B, 6.9B, 9.1A

FIRST AID:

HANDLING ADVICE:

Keep out of reach of children. Read label before use. Keep away from heat/sparks/open flames/hot surfaces. No smoking. Keep/Store away from clothing/combustible materials. Take any precaution to avoid mixing with combustibles. Do not breathe dust, fume, gas, mist, vapours or spray. Wash hands, face and all exposed skin

thoroughly after handling. Do not eat, drink or smoke when using this product. Contaminated work clothing should not be allowed out of the workplace. Avoid release to the environment. Wear protective clothing, gloves, eye/face protection and suitable respirator.

STORAGE AND TRANSPORT:

Store locked up in a cool dry place away from direct sunlight, sources of intense heat or where freezing is possible. Store away from foodstuffs, clothing and combustibles. Keep container tightly closed when not in use. Sites holding more than 100L or more of this product must hold a Hazardous Substance Test Certificate. Do not carry more than 700ml on a passenger service vehicle.

DISPOSAL:

DIRECTIONS FOR USE:

TRACE-IT MICRO IS SPECIFICALLY DESIGNED FOR ARABLE AND FIELD GROWN FODDER CROPS.

APPLICATION:

Trace-it Micro may be applied with most insecticides, fungicides or nutrient sprays. It is compatible with most chemicals, but for unknown or doubtful chemicals a test mix should be made up. Trace-it Micro should be added

to a partially filled tank with agitation running before most chemicals, except where a product label specifies otherwise. Always apply diluted or mixed chemicals immediately, do not store mixed chemicals.

WATER RATE:

For field use, use at least 100 litres per hectare.

CROP	APPLICATION RATE	APPLICATION TIMING
Cereals	1 – 2 L/ha	Apply during leaf and tiller development (GS30 – 32) and repeat if necessary between stem elongation and the booting stage (GS37 – 45)
Brassicas, fodder beat	1 – 2 L/ha	Apply beginning at 4th to 6th leaf stage and repeat as necessary at 14 day intervals
