### 4. FIRST AID MEASURES

**7. HANDLING AND STORAGE**

<b>Handling:</b>	Avoid eye contact and skin contact. Avoid inhalation of dust.
<b>Storage:</b>	Store in a cool, dry, well-ventilated place and out of direct sunlight. Store away from foodstuffs. Store away from incompatible materials described in Section 10. Store away from sources of heat and/or ignition. Keep container standing upright. Keep containers closed when not in use - check regularly for spills.
